We are pleased to inform that the National Centre for Cooperative Education (NCCE) under the aegis of National Cooperative Union of India (NCUI) has planned to organize six weeks paid certificate course on "Financial Accounting and Taxation" for the employees of cooperatives from 9th May to 3rd June 2022. This is a regular residential programme conducted by the NCCE in Delhi. The programme has been designed to enhance the knowledge and capacity of the employees of cooperatives on good financial management of their cooperative business. The course will cover topics such as book keeping, daily accounting, preparation of balance sheet, audit, filing of taxes, knowledge about new taxes and relevant laws etc. The course will be covered in six weeks times and the participants will be awarded a certificate of participation.

The Covid-19 pandemic has devastated people in the country. The cooperative and members are also facing tough challenges and cooperative business is disturbed. However, human resources are the strength of cooperatives. Hence, it is important to keep them abreast with skills and knowledge to manage their business in a competitive way, face the challenges and sustain in the market.

The following facilities will be provided by NCCE to attend the programme in Delhi:

- 1. 3 Tier AC / ordinary bus (to and fro) fare to the participants for attending programme after producing original tickets.
- 2. Boarding and lodging facility in the hostel of NCCE, Delhi
- 3. Training and course material

Please note that a fee of Rs.5,000/- will be charged for attending this course. You are requested to send nominations of suitable candidate(s) at the earliest so that we may confirm their admission well in time. A copy of the programme brochure is enclosed for your reference.

The participants should bring certificate of their both COVID 19 vaccinations. Further, as per Govt. of India's instructions, you are requested to communicate all the participants to carry a photocopy of their Aadhar Card in the training programme for necessary record.

You are requested to nominate 3 - 4 employees of your organization to attend this course. Preference will be given to women, SC/ST/OBC candidates. Smt.
